

WPRD Meeting Minutes for January 2026

Secretary Report: Copies of December meeting minutes were read by members. Motion to accept minutes was made by Kim Gorton, and 2nd by Leigh King. Motion carried.

This will allow more time for all necessary paperwork to be gathered leading up to the end of December.

Public Relations: Holly Shine was injured in a horse accident, and will be having surgery on her leg. Ona will get her address to send a card from the club.

Tack Swap: March 28th 2026 at New Beginnings Church, forms are on the website, as well as included in welcome packet that is being mailed.

Old Business: Kim Gorton was selected as the 2026 points secretary. Show secretary still needs to be filled, Alexis has had little to no interest and no applications for this position. Possible Michelle Harris, Alexis will reach out. WPRD apparel is available on the website to order. Newsletters and all other

forms (points packets, sponsor form, stall reservations, and membership) all on the website as well. Alexis mentioned allowing for more postage \$ in to the budget to be able to send all forms as a packet to members so it can be received all at once. Online entries not yet available, Alexis is hoping to have that ready by the February meeting.

New Business: Alexis was required to give treasurer Nicole, and secretary Emma the Commonwealth of Pennsylvania bureau of Corporations and Charitable Organizations Annual report forms. A sponsor secretary is still needed for the 2026 show season. Possibly Raegan Sweeny, Alexis will reach back out. Will ask Samantha Black if Raegan isn't interested. High point buckle sponsors were presented, looking for 14 sponsors for champion buckles at \$150 a buckle. 4 buckles already claimed- waiting on payment. We also have a ton of ribbons left over, hopefully none will be needed for this year, we have atleast enough to start us out we can order more in the later on if needed.
